**This Certificate is issued subject to the following conditions:**

1. The House should get Local Body License from the Block Development Officer and the Panchayat concerned also.
2. Building Stability Certificate should be obtained from PWD.,
3. OCCUPATOON CERTIFICATE (குடியேற்றும் சான்றிதழ்) (Section 26, 33, 38, 44 of Tamil Nadu public health Act 1939) should be obtained from Public Health Department.
4. NOC from Fire Service should be obtained and renewed every year.
5. Notifiable Infections if noticed among any occupants to be informed To the Local Health Authority under Section 64 of the Tamil Nadu Public Health Act 1939
6. Protected water supply should be provided to the stayers and eaters in the House.
7. The drinking water sources chlorinate by using 4 grams of Bleaching powder for every 1000 liters of water.
8. The employers of the House should be obtained medical fitness certificate from a Government Doctor to avoid any infected persons.
9. The floor swabbing of rooms, kitchen and dining hall areas with necessary disinfectants like phenyl and soap water.
10. Sufficient quantity of disinfectants to be stored for cleaning purpose and the stock should be maintained in proper Register.
11. Proper Drainage should be arranged to exit the water.
12. The house should be kept white washed every year.
13. Smoking Room should be provided separately under the COTPA Act 2003.
14. An Health Inspection book to be kept in the lodging premises to Enable the visits of Health Officials to enter their valuable suggestions.
15. All Public Health Standard Norms to be adopted as per the Tamil Nadu Public Health Act 1939.
16. This certificate issued is liable to be cancelled at any time on infringement of any of the above said conditions and for improper maintenance of sanitation, Improper maintenance of the building as well as toilets in the House
